###### B.3. Type of allocation of quota places:

Quota places are allocated to the athletes by name. NOCs with more than two (2) qualified athletes have the authority to decide in consultation with the respective NF, which two (2) qualified athletes they will enter.

##### C. ATHLETE ELIGIBILITY

###### C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).



Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the Competition Rules and Regulations of UIPM, may participate in the Olympic Games Paris 2024.

**C.2. Additional IF eligibility criteria**

Only athletes who competed in the Riding discipline without elimination or disqualification in a competition count for their UIPM Olympic Pentathlon World Ranking (OPWR) as described under **D.1 Quota Places/UIPM OPWR** may participate in the Olympic Games Paris 2024.

**D.1. QUOTA PLACES**

3	<p><b>UIPM 2024 Pentathlon World Championships – Zhengzhou (CHN), 9-16 June 2024</b></p> <p>Three (3) quota places will be allocated to the three (3) highest placed athletes at the UIPM 2024 Pentathlon World Championships unless previously qualified via the UIPM 2023 World Cup Final or the UIPM 2023 Pentathlon World Championships or the Continental Championships in which case the quota place(s) will be allocated to the next highest-ranked athlete(s) on the UIPM Olympic Pentathlon World Ranking list as of 17 June 2024.</p>

## D.2. HOST COUNTRY PLACES

The host country is guaranteed one (1) quota place per gender, if not otherwise qualified.

## D.3. UNIVERSALITY PLACES

Two (2) Universality places per gender are made available to eligible NOCs at the Olympic Games Paris 2024. On 1 October 2023, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality places. The deadline for NOCs to submit their requests is 15 January 2024. The Tripartite Commission will confirm, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

## E. CONFIRMATION PROCESS FOR QUOTA PLACES

### E.1. CONFIRMATION OF QUOTA PLACES

Following each qualification competition, the UIPM will publish the result on its [website](#) within 48 hours after the end of the competition. The qualification system closes at 23:59h (Monaco local time) on 17 June 2024. On 18 June 2024, the UIPM will inform the respective NOCs of their allocated quota places. The NOCs will then have six (6) days, until 23:59h (Monaco local time) on 24 June 2024, to confirm if they wish to use these quota places, as detailed in paragraph **G. Qualification Timeline**.

### E.2. CONFIRMATION OF HOST COUNTRY PLACES

The host country must confirm in writing to the UIPM by 23:59h (Monaco local time) of 16 June 2024 the use of its host country places.

## F. REALLOCATION OF UNUSED QUOTA PLACES

On 25 June 2024, the UIPM will inform the respective NOCs of reallocated places. The NOCs will then have six (6) days, until 23:59h (Monaco local time) on 1<sup>st</sup> July 2024, to confirm if they wish to use these quota places, as detailed in paragraph **G. Qualification Timeline**. Further reallocation, if necessary, will then take place until the reallocation period closes on 2<sup>nd</sup> July 2024.

### F.1. REALLOCATION OF UNUSED QUOTA PLACES



If an allocated quota place is not confirmed by the NOC by the confirmation of quota place deadline of 24 June 2024 or is declined by the NOC, or the athlete is not eligible according to the requirements under **C. Athlete Eligibility**, the quota place will be reallocated to the next highest-ranked eligible athlete on the UIPM Olympic Pentathlon World Ranking list as of 17 June 2024, not already qualified. When reallocating, the minimum continental representativity as described under **D.1 Quota Places/Continental Championships** must be checked. Should the minimum continental representativity has not been respected, or in case of necessary reallocation for a continental quota place, the next highest-ranked athlete on the UIPM Olympic Pentathlon World Ranking list as of 17 June 2024 not already qualified from the respective continent will be qualified.

## F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES

Unused host country place(s) will be reallocated to the next highest-ranked eligible athlete on the UIPM Olympic Pentathlon World Ranking list as of 17 June 2024 not already qualified.

## F.3. REALLOCATION OF UNUSED UNIVERSALITY PLACES

Any unused Universality place(s) will be reallocated to the next highest-ranked eligible athlete on the UIPM Olympic Pentathlon World Ranking list as of 17 June 2024 not already qualified.
